1. Treasurer's Report

- Welcome and thank you to John for stepping up to be our new Treasurer. We are so happy to have you!
- Anyone that had bank access, most likely lost access. We are going through the process of re-adding people. People can still log in, you just can't see anything. You need to be re-invited by John or Janell to receive access again.
 - If you do your personal banking at US Bank, you may need to call US Bank Online Banking support and ask for their help with still having access to both.
- Need to find out from Schram & Associates regarding 23-24 taxes, as review for 24-25 taxes that are upcoming.
- Another finding...\$5 fees charged monthly to a few accounts. It was a new fee to accounts that have been dormant for more than 18 months. At 24 months, those accounts money goes to the state. (Photo, Judo, Project Unify & Gymnastics)
 - John will contact Christy about Judo, Photo & Project Unify.
 - Brooke will contact the new coach (Elle Schlect) about the Gymnastics account.
- \$40 Transfer Fee for each club. Set to transfer fees on February 15, 2026. John will check accounts to make sure clubs are all okay financially for their transfer first.
- Zeffy Update: Well-oiled machine, chugging along.
 - Tap-to-pay is live on Android. It's a little glitchy, make sure you have it enable in your user account. Let Jenny know if you need a little help and she can explain it pretty quickly.

 - John looked at different licenses in Tech Soup, Quickbooks, Quicken. Spoke with Jim Smith about Expensify that he uses. John would like to test them to see how they work.
 - Jenny would need someone to create parentrep@krboosters.org email to set up and try it out.
 - Janell will contact rep at USBCA about using Zelle and creating online registers and direct reimbursements.
 - Jenny wondering about using Benevity. Typically takes a few months to see the donations made through Benevity.
- Our Microsoft account expired. Need to renew, only with a free account now.
- Recommendations for Senior Posters:
 - Koa at SunSigns (Ask Janell for more info if needed). 18x24 - \$20 & 18x36 - \$30.
 - 70% off at Walgreens, poster...\$15/paper poster (Ask Jenny Buron)
 - John Flanigan would like to make an effort to have teams senior posters ready so that they can go up in the gym for the whole season.
- Help File – random helpful info for parent reps would be nice.
 - Concessions rentals – comes out of Booster Club.
- Put out feelers for new Booster Club President (Brooke)
